Ms. Rogers, LUT President, invited the Board of Education to an educational symposium on Wednesday, May 1, 2013. She handed out an invitation with details on the conference.

Colleen Napoli 523 Sand Hill Rd, Wantagh, NY

Ms. Napoli was concerned about the Common Core and the scheduled tests. She is opposed to the high stakes testing and its one size fits all approach with little regard to the current performance of our district and the emotional and physical toll taken on the students and teachers. Ms. Napoli stated that the mandated tests bring with it unfunded costs that strain our district's budget while benefiting no one. She discussed some of the research she has done on these tests. Ms. Napoli remarked that several districts throughout the state have adopted resolutions, informing the state that the testing is not appropriate for our children. In looking at the Common Core, she believes that testing is for districts on the watch list. Ms. Napoli is extremely pleased with the education her children are receiving but feels there is too much testing. She handed out copies of resolutions others districts have adopted regarding standardized testing along with other pertinent information. She requested that the Board consider adopting a similar resolution.

RESPONSE:

Mr. Pappas responded that the Board would review the data but could not promise a resolution would be adopted.
