- A. Mr. Moran, President, called the Regular Board Meeting to order at 6:30 PM. On a motion by Ms. Adrian, seconded by Ms. Marenghi and approved (5-0) that the Board adjourn to Executive Session for the purpose of discussing the employment history of various employees.
- B. The Board reconvened to Public Session at 7:35 PM on a motion by Ms. Lang seconded by Ms. Adrian and approved (5-0). Mr. Moran asked everyone to stand for the Pledge of Allegiance which was led by Nicole Bowe, a Wisdom Lane student. She then spoke about Pearl Harbor Remembrance Day followed by a moment of silence for all our military forces past and present.

II. <u>REPORTS</u>

A. Student Presentations

i. Musical Presentation: MacArthur Winter Wind Ensemble

Dr. McDonald thanked the musicians, who performed holiday music in the auditorium for a wonderful enjoyable performance. She commented it was a nice way to get into the holiday spirit.

ii. Student Presentation: Wisdom Lane School – "Middle School 101"

Mr. Avena, Principal of Wisdom Lane Middle School, thanked the Guidance Department for their help in the presentation for tonight. He explained that three years ago a decision was made to put together a program to help middle school students transition from elementary school to middle school. He stated that this was for not just for their academic performance but for their social and emotional growth also. Students from each grade spoke about the program. They talked about the many areas that will help them be successful in school with topics such as: who to talk to, goal setting; good study skills, importance of using an agenda book, and stress management. A short video was shown.

B. Recognition

i. Student Art Display: Wisdom Lane School

Dr. McDonald acknowledged the beautiful art work adorning the Board room and hallway.

ii. Fall Scholar Athletes

Mr. Winch introduced Mr. Snyder, Director of Physical Education, Athletics, Chairperson of Physical Education, MacArthur High School, who welcomed the student athletes and their coaches. He thanked the Board of Education, Administration and parents who continually support these students. Mr. Snyder recapped the year by reporting that between the two high schools, there were four scholar athletics, twenty-eight all conference, six all class, nine all county, three all division and two scholastic award winners. He noted that there were playoff teams in girls soccer, boys soccer, girls volleyball, football and girls swimming won the Conference Championship. He stated that two coaches were retiring and spoke of them fondly. Mr. Snyder commented that he was proud of all of these athletes.

C. Superintendent

1. Comments and Reports

a. Eagle Scout

Dr. McDonald reported that a Division Avenue Boy Scout, Jake Martin, completed his Eagle Scout Project which was to research all graduates from Division Avenue who served in the military. She noted that a brick was laid for each one of these graduates in front of Division. She encourages everyone to visit as it is absolutely beautiful. Dr. McDonald commented that we are very proud of him and the Veterans who attended our schools.

b. Change for ESL Students

Mr. Winch shared that one of the programs the district has been reviewing is the English as a New Language Program formally the English as a Second Language Program. He noted that currently the program is offered at Summit, Northside and Abbey and all of those students that require services move on to Salk and MacArthur. He stated that after researching the program, it was determined that 70% or more of students re really zoned for Wisdom and Division. Mr. Winch stated that the districts philosophy is that students should attend the schools that they are zoned for as often as possible so that they are closer to their homes. He remarked that we are considering changing the secondary model which is also in alignment with the Utilization Study that we have been looking at where Salk and MacArthur are at maximum utilization. He stated that by transitioning the program over to Wisdom and Division, we are better utilizing these schools which are at 55% utilization. To recap, Mr. Winch noted that the elementary schools would remain the same but starting with next year's sixth grade, we would slowly phase in the Wisdom/Division schools. Dr. McDonald stated that it would be a very slow phase in over three years.

Ms. Wynn, Student Liaison for MacArthur, reported on the events at her school: a new entrant breakfast for students new to the District was held; AP Government students took an educational trip to Boston; the play "The Addams Family" had three exceptionally successful performances; ABA students went skating at United Skates of America; a 9th grade Parent workshop was conducted; the Annual Teachers Choice Breakfast was held; the Art Honor Society had a Gingerbread House Workshop; two students will be representing our school at the HOBY Conference at Adelphi University; Ms. Davidian, the former Math Chairperson was inducted in the Mathematics Hall of Fame; and concerts will be performed throughout the month.
