#### MINUTES

**THE REGULAR MEETING OF THE BOARD OF EDUCATION** was duly called and held on Wednesday, March 15, 2017 in the Board Meeting Room of the Levittown Memorial Education Center.

### I. CALL TO ORDER

- A. Mr. Moran, President, called the Regular Board Meeting to order at 6:15 PM. On a motion by Ms. Adrian, seconded by Ms. Marenghi and approved (6-0) that the Board adjourn to Executive Session to seek legal advice from the Board's Attorney.
- B. The Board reconvened to Public Session at 7:40 PM on a motion by Ms. Marenghi seconded by Ms. Adrian and approved (6-0). Mr. Moran asked everyone to stand for the Pledge of Allegiance which was led by the MacArthur High School Sign Language Class. Mr. Moran requested a moment of silence for our service men and women.

## II. <u>REPORTS</u>

## A. Student Presentations

Student Academic Presentation - MacArthur High School Sign Language Class

MacArthur's Sign Language Class teacher, Ms. Tully, commented that she is a former "General." She gave a brief overview of the course and stated that she had 22 energetic students in her class learning to master sign language. Ms. Tully shared that she was personally inspired by them to learn herself. A short video was shown followed by a demonstration by the students.

## Student Art Presentation – MacArthur High School

Dr. McDonald thanked the students from MacArthur High School for the beautiful artwork which is spectacular. She asked everyone to view the items in the old phone booth in the hallway.

Additionally, Dr. McDonald announced that for the last four year's MacArthur has produced an award winning PSA video for the County of Nassau. The video was shown.

Dr. McDonald shared that Mr. Mulligan, Assistant Principal for Salk Middle School, was honored by being named an "Educator of Character."

### Valedictorian and Salutatorian – Division Avenue High School

The Principal and Assistant Principals of Division Avenue were called up to introduce this year's Valedictorian and Salutatorian. A brief summary of their achievements and honors during their high school careers was given. The Board of Education and Administration congratulated them and presented them with awards.

### Hofstra Spelling Bee Winners

Mr. Winch outlined a brief history of the Scripps National Spelling Bee which students from our elementary and middle schools participated in. He advised that the goal of the National Spelling Bee is to help students improve their spelling, increase their vocabulary, learn concepts and develop correct English usage that will help them all their lives. Mr. Winch announced the finalists and asked them to spell the last word that they spelled during the competition. He noted how proud we all are of them. Dr. McDonald commented you will always remember these words.

## **2.** Budget Presentations

A. PTA Advisory Committee on the Budget

Ms. Silberger, a representative from the PTA Advisory Council, gave a brief report on recommendations from the Council. She stated that her budget committee is represented by the Parent Teacher Associations for all the schools, GC Tech and SEPTA. Ms. Silberger advised that all units presented many questions regarding instruction, technology, athletics and building and grounds. This year, she noted, that no questions were raised on staffing and everyone appreciated that the proposed budget did not include staff reduction. She shared that similar to prior years, many of the concerns presented were already in the process of being addressed by the District. Some of these items are the expansion of the IXL Math Program, the financial support of elementary clubs, and the beatification of the high schools. The Council hopes that the following items can be addressed in the new budget: more cohesive use of tablets in the classroom; continued funding for STEAM activities specifically the use of the Outdoor Learning Center; the building management system; painting for the general use areas and main lobby of Division; refurbish the downstairs Band Room and replace the blue stone at Wisdom; replace turf fields; refurbish MacArthur Auditorium; Northside Cafeteria; review safety inside the buildings; and reevaluate traffic patterns. Ms. Silberger remarked that she is proud of the Levittown School District and grateful for the progress the District has made addressing the Council's concerns. She stated that the PTA continues to appreciate the support of all students, meaningful instruction, sound budget, safe and well maintained buildings and top notch staff. Additionally, she thanked the Board of Education and Dr. McDonald for all their hard work and dedication to the students and families of Levittown. She also thanked Mr. Pastore, Mr. Winch, Dr. Sturz and Mr. Milano for meeting with them and answering every last question they had. Dr. McDonald thanked the PTA Committee for their careful work and she found them a pleasure to work with.

Mr. Pastore presented an update on the budget in which he noted that we are pretty far along in the process. He stated that at the next meeting on March 29<sup>th</sup> the Board will be asked to approve the Budget. Mr. Pastore hoped at that time to have better state aid numbers. He shared that in April the Property Tax Report Card is due and the Budget Hearing is scheduled for May 3<sup>rd</sup> with the Budget Vote on May 16<sup>th</sup>. Mr. Pastore discussed some small changes that were made to the budget but noted that the District is staying within the tax levy limit. Mr. Pastore stated that our budget-to-budget increase is 2.32% which is slightly down for last time. He explained the four propositions on the ballot;

the school budget, create a new Capital Reserve, use the current Capital Reserve and library budget.

Mr. Pastore went on the discuss these propositions. Dr. McDonald commented that we are asking the community to allocate money that is already in our reserve at no cost to the taxpayer. She noted that it was wise for the Board to establish the Capital Reserve Fund in 2013 which has given us the opportunity to save the money to do necessary projects. Dr. McDonald stated this was "forward thinking." Mr. Pappas remarked that the community should be educated that this money isn't tax income. Dr. McDonald pointed out that we will work with Syntax to make sure the literature is very clear and in layman's terms.

Ms. Marenghi shared that she attended the Reform, Education, Financing and Equities Today Meeting (R.E.F.I.T.), which is a group that lobbies our Legislature for additional state aid. She felt the climate of the meeting was very positive. She reported that there were discussions on tax credits for private and procrochial schools and charter and public schools funding. Additionally, they did not see mid-year cuts happening. Ms. Marenghi commented that the meeting was refreshing and quelled a lot of our fears.

#### **PROPOSITION NO. 2**

CREATION OF THE 2017 CAPITAL RESERVE FUND FOR SCHOOL BUILDING IMPROVEMENT PROJECTS

BE IT RESOLVED, that the Board of Education of the Levittown Union Free School District is hereby authorized, pursuant to Section 3651(1) of the Education Law, to establish the 2017 Capital Reserve Fund for the purpose of financing District-wide capital improvements including site work, construction, reconstruction, renovation and equipping of school buildings and facilities, with the ultimate amount of the 2017 Capital Reserve Fund to be \$25,000,000, the probable term to be ten (10) years and the source of the funding to be (i) amounts from budgetary appropriations from time to time, and (ii) unappropriated fund balance made available by the Board of Education from time to time, and (iii) authorized transfers from other available reserves in accordance with existing law, and (iv) New York State aid received and made available by the Board of Education from time to time.

#### **PROPOSITION NO. 3**

EXPENDITURE OF THE 2013 CAPITAL RESERVE FUNDS FOR SCHOOL BUILDING IMPROVEMENT PROJECTS

BE IT RESOLVED, that the Board of Education of the Levittown Union Free School District, be hereby authorized to expend the remaining funds from the District's 2013 Capital Reserve Fund, previously established by the voters of the District, an amount not to exceed fourteen million five hundred and sixteen thousand dollars (\$14,516,000) to undertake and perform school building improvement project(s) ("Projects") as described in the District's Budget Brochure ("Brochure") on file in the office of the District Clerk; the Projects to commence during the 2017-2018 school year and to consist of capital improvements, renovations and/or alterations to all District Buildings, including but not limited to: bathroom renovations at the Division Avenue High School and General Douglas MacArthur High School, replacement of turf fields at the Division Avenue High School and General Douglas MacArthur High School, replace the track at the Division Avenue High School, refurbish and renovate the auditorium at the General Douglas MacArthur High School, improvements, renovation and new construction related to improving traffic flow at various district sites and construction of an all-purpose room and cafeteria at the Northside Elementary School; including necessary equipment and related work, as well as preliminary and incidental costs; and that the specified Project costs as set forth in the Brochure may be reallocated among the Project's components within the scope of this authorization.

#### **PROPOSITION NO. 4** LIBRARY BUDGET

RESOLVED, that the Public Library Budget for the fiscal year 2017-2018 proposed by the Library Board of Trustees of the Levittown Public Library heretofore filed pursuant to law shall be approved and the necessary taxes be levied therefore on the taxable real property of the district.

NOTICE IS FURTHER GIVEN, that petitions nominating candidates for the office of member of the Board of Education and for the office of member of the Library Board of Trustees must be filed with the Clerk of the District between the hours of 8:00 AM and 5:00 PM but no later than 5:00 PM on April 17, 2017. Forms of the petitions may be obtained from the Clerk of the District.

The following vacancies are to be filled on the Board of Education: Two (2) members for the term of

three (3) years, commencing July 1, 2017 and expiring June 30, 2020, One (1) member for the term of three (3) years commencing May 16, 2017 and expiring June 30, 2020.

A separate petition is required to nominate a candidate for member of the Board of Education. The candidate receiving the highest number of votes will be elected to the seat commencing May 16, 2017 and expiring June 30, 2020. The candidates receiving the second and third highest number of votes will be elected to the seats commencing July 1, 2017 and expiring June 30, 2020. Each petition must

be directed to the Clerk of the District, must be signed by at least twenty-five (25) qualified voters of the District, or 2% of the voters who voted in the previous election, whichever is greater, and shall state the residence of each person who signed, must state the name and residence of the candidate and the length of the term of office. This year all nominating petitions must include 54 signatures.

The following vacancy is to be filled on the Library Board of Trustees: One (1) member for the term of five (5) years, commencing July 1, 2017 and ending June 30, 2022, to succeed Rusel Greller last incumbent.

A separate petition is required to nominate a candidate for member of the Library Board of Trustees. Each petition must be directed to the Clerk of the District, must be signed by at least twenty-five (25) qualified voters of the District, or 2% of the voters who voted in the previous election for members of the Library Board of Trustees, whichever is greater, and shall state the residence of each person who signed, must state the name and residence of the candidate and the length of the term of office. This year all nominating petitions must include 53 signatures.

NOTICE IS FURTHER GIVEN, that a statement of estimated expenses for the 2017-2018 school year will be presented at a Public Hearing on Tuesday, May 3, 2017, at 7:30 PM in the Board Meeting Room of the Levittown Memorial Education Center and copies of such statement, as well as the statement of the amount of money required for the 2017-2018 fiscal year of the Public Library, will be made available on the District's website and at each schoolhouse and library in the District during the hours of 9:00 AM and 4:00 PM on each day other than a Saturday, Sunday or holiday during the fourteen (14) calendar days immediately preceding the election together with the text of any resolution which will be presented to the voters.
