MINUTES

THE REGULAR MEETING OF THE BOARD OF EDUCATION was duly called and held on Wednesday, November 15, 2017 in the Board Meeting Room of the Levittown Memorial Education Center.

I. CALL TO ORDER

A. Ms. Marenghi, President, called the Regular Board Meeting to order at 6:30 PM. On a motion by Ms. Adrian, seconded by Ms. Lang and approved (5-0) that the Board adjourn to Executive Session for the purpose of negotiations conducted pursuant to the Taylor Law involving the ALSA and LUT Unions.

B. The Board reconvened to Public Session at 7:30 PM on a motion by Mr. Cain seconded by Ms. Lang and approved (5-0). Ms. Marenghi asked everyone to stand for the Pledge of Allegiance which was led by students from Northside School. Ms. Marenghi requested a moment of silence for all the men and women serving our country at home and abroad. Additionally, she asked for us to remember Taranjit Parmar, a honor graduate of Division Avenue High School who was lost her life over the weekend.

NOTE: Student Presentations and Recognition were taken out of order and presented before the Audit Committee Meeting.

II. <u>REPORTS</u>

- A. Student Presentations
- i. Academic Presentation Northside Summer Reading

Mr. Winch asked Mr. Mortillaro, Principal of Northside School, and Ms. Slattery, Director of English, to highlight the Summer Reading Extravaganza. Mr. Mortillaro introduced the teachers, Assistant Principal, and students who will be presenting. Ms. Slattery introduced the Librarians from Northside and the Levittown Public Library who supported our reading efforts. She reported that current research shows that the average student will lose approximately one month of instruction during the summer break. To avoid this loss, it is imperative that students read over the summer to maintain comprehension and vocabulary skills, as well as to strengthen their ability to analyze information and think critically. Mr. Mortillaro advised that reading is so important, and it is important that we motivate children to want to read. He remarked that this program helped children get excited about literature. A slide show was presented which showed the programs journey from inception to completion and highlighted what the Summer Reading Extravaganza was all about. Ms. Slattery commented that this was more than a program, it was an extravaganza! She noted that a lot of work goes into making a program such as this but it is a labor of love for everyone. The novel chosen was Escape From Mr. Lemoncello's Library by Chris Grabenstein. The Board and Administration thanked everyone for this wonderful experience for the children.

ii. Presentation – Division Avenue High School – Distracted Driving

Dr. Sturz spoke about LEADD (Levittown Education Against Destructive Decisions) Week. He noted that traditionally the week-long program is focused on alcohol and substance abuse prevention. Dr. Sturz remarked that this year, Division took on an innovative project – distracted driving. He asked all of Division Avenue's Administrators to come up front. He introduced all of the Peer Leader students and Mr. Verdi, an English teacher. Dr. Sturz acknowledged all the wonderful things that Mr. Verde does for the school and community. The students expressed their desire to bring awareness to the issue of destructive driving. They acknowledged that distracted driving has become a huge problem that we are all guilty of. An incredible video was shown of the various ways the students could get their message across. The Board thanked the Peer Leaders and Mr. Verde for an open discussion about this project.

Ms. Battaglia went over some of the highlights of the financials for the fiscal year 2017. She reviewed some of the new additions this year to the financial statements. She noted the District has a healthy balance sheet and that she found nothing out of the ordinary was found. Ms. Battaglia thanked the Business Office and Mr. Pastore for providing the documents necessary to complete the Audit in a timely fashion. Mr. Pappas had questions for the Auditor on workers compensation and unemployment insurance, and revenues over budget. Ms. Battaglia responded to these questions. Dr. McDonald commented that Audits are stressful and require a lot of work. She thanked the Auditors for helping to mediate the process.

Ms. Adrian noted that she and Ms. Rifkin recently had the opportunity to attended a Sexual Assault Training Workshop at Hofstra Law School in partnership with the DA's Office. She commented that it was very interesting and it gave you many issues to think about especially the proper ways to communicate. Ms. Rifkin agreed that we have to be cautious about how we use social media with our students.
