I. CALL TO ORDER

- A. Ms. Marenghi, President, called the Regular Board Meeting to order at 6:30 PM. On a motion by Ms. Adrian, seconded by Ms. Lang and approved (6-0) that the Board adjourn to Executive Session for the purpose of negotiations conducted pursuant to the Taylor Law involving the CSEA.
- B. The Board reconvened to Public Session at 7:30 PM on a motion by Mr. Cain seconded by Ms. Lang and approved (6-0). Ms. Marenghi asked everyone to stand for the Pledge of Allegiance and requested a moment of silence for all the men and women serving our country at home and abroad.

B. Recognition

Student Art Presentation - Northside School

Ms. Marenghi thanked the students from Northside for the lovely art work in the Board Room and hallway. She pointed out the beautiful sunflowers on display.

C. Superintendent

1. Comments and Reports

A. Levittown for Levittown

Dr. McDonald remarked that the District has been working on the Levittown to Levittown Fundraiser. She noted that the monetary portion has come to an end, raising approximately \$14,000. She thanked Michelle Ortiz for all her help and hard work, especially since the schools had no electricity or phone service. Dr. McDonald noted that Michelle was able to identify five schools within the Levittown, Puerto Rico area, four elementary and one high school. She stated that the most recent communication Ms. Ortiz had with the schools is that the high school still does not have electricity. Therefore, they are requesting a generator be bought with the money raised. The Board had a discussion on how best to use the money collected. Several suggestions were made and the final decision was to ask each school what they needed and see if we have enough money to purchase it. Additionally, Dr. McDonald noted that the District had some old athletic uniforms that just said "Levittown" that will also be sent to the schools.

B. Presentation on Turf Fields - Laser

Mr. Pastore reported that the District is in the process of installing new turf fields. He noted that we are in litigation with the previous company, Field Turf, that provided the turf. Mr. Pastore introduced Mr. Anthony Gulino, a representative of Laser, the company we plan on using to install the turf. Mr. Gulino, discussed the different types of turf and the process used to install it. He noted that the District's building and grounds crew would be trained on how to groom the fields. Mr. Pastore stated that we would like to start the process this winter at the MacArthur field and have it ready for spring sports. The Board asked questions such as the warranty period, drainage and logos. A student in the audience had a concern regarding the net that will surround the turf field since he is on the cross country track and field team. Mr. Gulino remarked that overlapping openings will be put in the netting to accommodate these individuals who walk through. Dr. McDonald asked the football players in the audience if they would want a piece of the old field. They responded enthusiastically affirmatively.

Erin Cassano, the student representative from MacArthur High School, reported on the events at her school: several members of our Art Honor Society conducted our annual gingerbread house workshop for elementary students in the District; sixty-six senior students were honored at the annual General's Breakfast; final exams will be administered in the next few weeks; the New York State Public High School Athletic Association designated MacArthur High School with their coveted "Award of Excellence" for outstanding display of sportsmanship, ethics, and integrity.

Student Liaison, Sonia Inderjit, shared the events at Division Avenue High School: two seniors were recently matched through the QuestBridge College Placement Program and will be attending Emory and University of Chicago where they will receive full scholarships; two seniors were honored as Nassau Zone Outstanding Physical Education Students; a senior was selected as a semifinalist in the 2018 Coca-Cola Scholars Program for her exceptional leadership skills, academic abilities and community service; two students received an Honorable Mention at the 2017 St. Joseph's Hospital Photography Contest; the Science Olympiad Team earned five medals at an Invitational; in-class, midterms and Regents will be taking place shortly.
