I. CALL TO ORDER

- A. Ms. Marenghi, President, called the Regular Board Meeting to order at 6:30 PM. On a motion by Ms. Adrian, seconded by Ms. Lang and approved (7-0) that the Board adjourn to Executive Session for the purpose of negotiations conducted pursuant to the Taylor Law involving the CSEA."
- B. The Board reconvened to Public Session at 7:30 PM on a motion by Mr. Cain seconded by Ms. Adrian and approved (7-0). Ms. Marenghi asked everyone to stand for the Pledge of Allegiance and requested a moment of silence for all those serving our country at home and abroad.

B. Recognition

iv. Student Art Presentation by Salk Middle School

Ms. Marenghi asked everyone to view the beautiful artwork by the students from Salk Middle School and thanked them for a lovely display.

v. Eagle Scout Recognition

Ms. Coscia, Principal of Division Avenue High School, introduced Jonathan Swift who achieved the rank of Eagle Scout which is the Scout's highest rank. He commented that Mr. Swift is a quiet, unassuming and dedicated student. Mr. Swift's project was to support the Levittown Community repairing and upgrading the school kitchen in St. Bernard's Catholic Church. The Board congratulated Mr. Swift on his achievement.

Ms. Rifkin commented that tonight it was her pleasure to honor some of the District's finest, newest teachers that have been with us for three to four years and are being appointed tenure. 3. Follow-up to Board Questions

Mr. Winch responded to questions asked by the Board in regards to his presentation on RtI at the last meeting on. He noted that one question was related to the programs and strategies used to support reading instruction. He handed out a chart covering this topic. He noted that if the Board wants further information he would need more specific direction from them. The other question was on the numbers of students being identified in each tier as progress through the grades. Mr. Winch shared that over the summer his department would be doing an in-depth project on this subject.

Mr. Pastore gave a presentation on our Fund Balance and Five Year Projections. He commented that he recently attended a Conference which was also attended by auditors, accounts and business officials. He noted that the meeting reviewed what the State Controller is doing with the new reserves, and gave an update on the Fund Balance and Reserves and technical changes in the GASBY. Mr. Pastore went over our Fund Balance and handed out a spreadsheet of his five year projections for year end. He discussed his estimates and explained that the numbers on the worksheet tie into his budget documents. He shared that he does projections on expenditures such as employee benefits and payroll and revenue. Mr. Pastore advised that we are in good shape and should keep doing what we are doing. Dr. McDonald explained that this report is different than prior reporting in that it is more complicated now. Mr. Pastore stated that at the next meeting he would have a more detailed report on the Fund Balance with plans for use. The Board had questions on our reserves, employee benefits, unemployment and workers compensation. Mr. Pappas thanked Mr. Pastore for an amazing job to help clarify the budget for the layman.
