## II. <u>REPORTS</u>

#### A. Student Presentation

## i. Eagle Scout Presentation – Brandon Smith

Brandon Smith spoke about his Eagle Scout Project which is to build two Bocce Ball courts at the Kevin Regan Sports Complex. They would be located in the back area by the garage so that it would be accessible to the public. He handed out pictures of what the courts would look like. Mr. Smith reported that he did a survey of the community and found that there is a need. He noted that the nearest Bocce Ball court for anyone to access is in Eisenhower Park which is a further drive. He shared that additional research found that there is a Bocce Ball Team who would like to use the courts for Tournaments. Mr. Smith mentioned that Legislature John Ferretti and Councilmen Dennis Dunne both liked his idea. He noted that he would be having fundraisers to help fund the money for this project and that District money would be used. Mr. Smith remarked that he wanted to give back to the community that has given so much to him.

### B. Recognition

Boys Baseball – MacArthur/Division

Mr. Winch commented that in June we were honored to celebrate the achievements of our students during the Spring sports season. Unfortunately, our baseball teams were unable to attend that ceremony. Tonight we are thrilled to have them with us. Mr. Winch stated that the baseball teams at both MacArthur and Division made us extremely proud this year, advancing into the playoffs in traditional Levittown fashion. He noted that tonight we celebrate their success as teams and as individuals. Dr. McDonald mentioned that both of these teams placed all the flags at Abbey Lane on the day of their championship game against each other which showed how well they work together. Ms. Marenghi commented that it is always a pleasure to attend the games and the athletes are always gentlemen. The boys were called up to receive their certificates and congratulations from the Board and Central Office.

## B. Superintendent

### 1. Comments and Reports

### A. Unisex Bathrooms – Division/MacArthur

Dr. McDonald reported that the District submitted a proposal for unisex bathrooms at both Division and MacArthur High Schools to New York State which was denied. Dr. McDonald shared that our proposal was for six unisex stalls, three for girls and three for boys with two being handicap accessible. The State refused to approve this proposal because they said it was possible that all six stalls could be used by boys at the same time and therefore the girls would not be able to use their three stalls. Therefore, Dr. McDonald proposed that we move ahead and update both schools bathrooms but they will not be unisex. She noted that we will still have an issue with Transgender youth but we will figure it out.

#### B. AmazonSmile

Mr. Pastore shared that a couple of months ago a question was raised about the website AmazonSmile which is a way to donate when you make purchases through Amazon. He asked the Purchasing Agent, Bonnie Pampinella, to discuss this new initiative. Ms. Pampinella reported that the District has registered with AmazonSmile to receive donations from all eligible purchases made while shopping online and initiating your shopping trip at Smile.Amazon.com. She noted that for all eligible purchases, the AmazonSmile Foundation will donate 0.5% of the purchase price to the customer's selected charitable organization. She went on to explain the process used to make a donation. Ms. Pampinella noted that all of the Districts' requisitioners were recently sent a memo that explains how to use Smile.Amazon.com and all of their eligible purchases will automatically be donated to Levittown Schools. She added that on a personal level, community members can also donate by choosing Levittown Schools as their charity of choice which is a great way to give back to the District.

## Policy No. 5725 Transportation for Students in Foster Care - First Read

Mr. Winch reported that a Title I Desk Audit was done this year that required the District to adopt two new policies that are related to the Every Student Succeeds Act (ESSA). He noted that this policy states that we are required to work with local Department of Social Services to determine appropriate transportation for students who go into Foster Care while they are in our schools.

# Policy No. 8260 Title I Parent and Family Engagement - First Read

Mr. Winch shared that this policy replaces the Title I Parent Involvement Policy. He remarked that the previous policy was completely rewritten. Mr. Winch explained that the new policy is more specific to what is required. He commented that we already do what is required in this policy such as additional parent workshops and teacher parent meetings.
