On Wednesday, February 7th, DAHS Italian students enjoyed an in school field trip involving a program organized by Ms. Fuentes and Ms. Nielsen. The program was led by the BOCES sponsored Incanto Productions. Students learned about history, costumes, famous characters and many special qualities of each region of Italy during the world famous Carneavale. They participated by dancing, singing and asking questions to the artists and presenters; this cultural and educational experience was a great success. The DAHS robotics team competed at the Vex meet at Farmingdale HS on February 10th. The Art Department's talents were on full display in the Art Show at the Levittown Public Library on February 15th. Many thanks to Mr. Ryan, Ms. Cordiello, Ms. Roth, Mr. Brown, Ms. Lundy and the District Director, Mr. Creter for their unwavering support and efforts to the students of Division Avenue. The Science Olympiad team earned 4th place at Nassau East Regionals. They are headed to the NYS Finals in Syracuse for the 16th consecutive year at LeMoyne College on

March 15th. Boys basketball made the playoffs. Girls basketball won their first playoff game, in spite of losing a tough game to MacArthur in the second round. Emma Robins is in the top 10 in Nassau County scoring 17.5 points per game, and leading in foul shots, 8th grader Alice Beckett is averaging 13 points per game, 12 rebounds and 5 blocked shots, Junior Ashley Anderson is averaging 11 points per game. The Cheer team finished 16th out of 88 teams in the Nationals at Disney. They won the first Nassau County Championship for Cheer. The wrestling team had a great finish to the season with 12 all league wrestlers, 7 county qualifiers, 3 all county; Shane Moore, Santiago Pelaez and Caiden Siegel and all Long Island girls champ, Sam Bultron and one all state, Shane Moore. In winter track, our boys 4x200 meter team broke the school record and achieved the number 2 time in all of Nassau. The 4x400 team won the conference and Eleni Georgatos was the conference champion. The 4x200 team won county champs, the girls 4x200 and boys 4x800 both placed 4th. The DAHS girls basketball team dedicated their basketball court to former girls coach Steve Kissane, who had a 30 year career and won 352 games, 24 playoffs won a LI championship and built a program that continues to thrive. The bowling team will compete in the county tournament on Saturday, March 10th. The boys swim team placed 4th in Division C Championship meet. Junior Nick Castano finished 2nd place in the 100 fly, 100 back and will be competing on March 1st at Ithaca College. Noah Stern finished in 3rd place in the 200, 500 and 400 freestyle relays. Both will be competing in the County Championship meet on Friday, February 9th. Challenger homecoming is March 5th. DAHS sweeps is March 8th. The Addams Family performances will be Match 22 at 7:30 and March 23rd at 1:00 and 7:30.

On February 28th, we conducted the annual seniors superlatives ceremony. Categories such as most likely to succeed, nicest smile and most likely to be Broadway bound were some examples. They were voted on and winners for each were revealed. Thanks to Ms. Causeman and Mr. Reynolds and congratulations to all the winners. On February 24th, the Generals science research team participated in the ignite stem challenge at Princeton University. Students were given a variety of prompts relating to specific world problems and were tasked to make a new technology to combat these issues within 45 minutes. At the end of the session, our team presented their project to Princeton professors. On March 1st, our science research students competed at the NY American Chemagination tournament at St Johns University. Congratulations to Alyssa Aquino, Meghan Campbell and Catherine Purirogejanon for taking second place in the environmental category and to Cody Linn, Zarif Jamal and Matthew Wazio for taking 3rd place in the energy section. On March 1st, we conducted the Battle of the Classes. Events such as scooter race, pizza box race and the human caterpillar are just some of the fun battles we had. The sophomore class
