This year's end of the year celebration sponsored by Salk's Student Council will be an exclusive outing at Adventureland in Farmingdale on Tuesday, June 1st from 6:00-9:00 p.m. The cost of the trip will be \$35.00 per student. The cost of admission covers an exclusive outing for Salk students ONLY, rides, and faculty supervision. If students wish to purchase food, souvenirs or play other games at the park- they must bring their own money.

Adventureland is Long Island's Amusement Park since 1962 and we welcome your child to come and enjoy a fun filled evening on their rides, attractions, games and more. We will follow any NYS Covid-19 rules that Adventureland has in place and a mask **must** be worn by all for the entire event. Please see their website for any additional information.

This is a drop off and pick up event for Salk students only. Students will be dropped off at the rear entrance of the park NO earlier than 6:00 p.m. for check in. Students **MUST** be wearing their admission bracelet to enter. Bracelets will be handed out at school that day. Pick up will be staggered for safety reasons. Anyone picking up children in multiple grades **MUST** pick up all students in their carpool at the earlier dismissal time.

Pick Up Procedure: ** NO STUDENTS WILL BE RELEASED WITHOUT AN ADULT

1. ALL 6th graders will be released at 8:40 p.m. out the rear exit to the park.
2. ALL 7th graders will be released at 8:50 p.m. out the rear exit to the park.
3. ALL 8th graders will be released at 9:00 p.m. out the rear exit to the park.
